New patient services at Winchester Neurological consultants are very exciting: Drs. Lyons, Henry and Selznick work closely together to improve client services in this part of North-Western Virginia.

SURGERY

There have been 25 operations for epilepsy in Winchester with a 80 % success rate.

DIET:

There are now diet services (ketogenic diet, modified Atkins and non-glycemic diet) services for children and adults. Discussion with Lalia Hammer, RD Clinical Dietician with the Ketogenic Diet Program & Winchester Neurological show that Dr. Lyons will suggest diets to be considered if 2 medications have failed to control seizures. Three types of diets:


Classic Ketogenic: done on a gram scale, exact measurements 4:1, 3:1, 2:1 rations, ketones are checked regularly.

Modified Atkins: High fat, carb restrictive, protein not restricted, ketones are checked. Carb amounts are: 10g for child; 15g for teenager; 20g adults

Low glycemic index treatment: high fat, low carb, protein not restricted. 40-60g carbs allowed but all sources need to be low glycemic. Ketones are not checked.

All three diets are carefully monitored with blood work, but low glycemic needs to be monitored less frequently. Currently Winchester has 3 patients on the Classic and 10 patients on the Modified Atkins or low glycemic. All patients are responding well with seizure reduction by 50%, improved quality of life and less drowsiness. Medications are continued until they see that the diet is working, then Dr. Lyons and Lalia will work to bring patients off the medications. They ask patients to commit to the diet for 3 months to give it time. 50% of those that try it have a 50% reduction in seizures. There is ongoing research not only for epilepsy diets but other neurological conditions as well. Lalia states there are a lot of tools, resources and support available.

Lalia was accepted and attended a 2 ½ day conference hosted by KetoCal Nutria and Dr. Eric Kossoff from Johns Hopkins was there. He also came to speak at Valley Health neurological roundtables last Fall. Anyone interested in speaking with Lalia more or starting the program may contact her at (540)536-7698. Paul Lyons MD PhD also mentions: There have

been VNS and Neuropace implants and the "compassionate" use for epidolex (CBD oil) has been expanded to 5 children. The interesting matter Dr. Lyons remarked upon is the cognitive improvement of the two children on CBD oil and also significant seizure reduction. Dr. Lyons is interested in having hemp grown and tested in Virginia and is willing to cooperate with EFVA to get this so done.






Summer picnic for epilepsy heroes, July 11 Charlottesville 500 Ray C Hunt Drive 12-2 P.M.
